Measures taken to ensure that Programme Project Report for each programme is according to the norms and guidelines prescribed by the Commission and wherever necessary by the appropriate regulatory authority having control over the programme	The Programme Project Report (PPR) is initially prepared by expert programme coordinators under the norms and guidelines prescribed by the Commission. After drafting, the Head of the Department carefully examines the PPR along with a senior professor from the concerned department, and then the BOS&R of that department approves it. Following this stage, the Centre for Internal Quality Assurance (CIQA) plays a crucial role in reviewing and approving the PPR of all programmes. Whenever necessary, the committee may recommend modifications to ensure alignment with quality standards. The CIQA grants the final approval before the official launch of the programme. In addition to this, the CIQA is entrusted with the responsibility of collecting information from other Higher Educational Institutions (HEIs) regarding quality benchmarks, parameters, and best practices. 9. The first-hand print (sample) lessons are then printed by the printers concerned.
10. The sample copies of printed SLM is sent to the Course coordinators who again go through the vetting and finalize the lessons.
11. The final prints are then printed by the printer after approval and checking by the course coordinators.
12. The SLM is then delivered to the students.
13. The authors and vetters are remunerated as per the university rules.

Part – X: Innovative and Best Practices

10.1 Innovations introduced during academic year

For ODL Mode:

- 1) First one week online academic orientation programme was organized by the Centre for Distance and Online Education (CDOE) from the first week of November 2025 for the students admitted at the Centre for Distance and Education for the session 2025-26.
- 2) Online mentoring session of one hour per week has been organized for the students of all Programmes for ODL programme.
- 3) For the admitted students, the Centre for Distance and Online organizes Personal Contact Programmes (PCPs) during which the teachers of parent departments and the programme co-coordinators take classes and satisfy the queries of the students of CDOE for ODL programmes.
- 4) The students were also connected through WhatsApp, Facebook pages and E-mails and other social media pages.
- 5) Examinations were conducted for theory/practical exams, seminars and viva-voce for ODL Mode Programmes as per requirements.
- 6) Assignments are accepted through the online portal since the session 2018.
- 7) Three tier students grievance cell activated in the Centre for Distance and Online Education.
- 8) The admission criteria and the pass/fail criteria of the ODL programmes are identical to those of the conventional programmes.
- 9) CDOE accepted schemes, syllabi, and course curriculums for all courses at par with the regular courses.
- 10) Currently, the Centre for Distance and Online Education (CDOE) offers 03 undergraduate, 08 postgraduate (Online as well as ODL).
- 11) The Centre for Distance and Online Education offers 14 number of one year Diploma programmes/courses in ODL mode and 3 number of one year Diploma programmes/courses in ONLINE mode have been introduced for the benefit of students.
- 12) Currently CDOE got approval regarding the extension of territorial jurisdiction from the state government to create examination centers across Haryana to ensure the smooth conduct of examinations.
- 13) The Centre for Distance and Online Education offers several programmes in which the institution's self-learning materials (SLMs) are digitized and uploaded to the website or Learning Management System (LMS), ensuring easy access for students enrolled in online mode programmes.
- 14) From the session 2015-16 onwards, the online admission process was adopted to facilitate the students from all over India and abroad.
- 15) The Centre for Distance and Online Education (CDOE) implements the four-quadrant approach for its online programmes—comprising E-Content, E-Tutorial, E-Assessment, and Discussion Forum—in accordance with the UGC Regulations, 2020 (ODL & Online Programmes).
- 16) The Centre for Distance and Online Education is at present offering number of jobs oriented programmes including MBA and B.Com (ODL Mode/ONLINE) which are approved by the UGC (DEB).

10.2 Best Practices of the HEI

In the last five years, the following are the improvement/updation w.r.t. functioning and results of CDOE.

1. Student counseling regarding distance and open learning in various educational institutions like colleges and study centres are being followed from time to time.
2. Orientation programme in the form of induction trainings are being imparted to make aware the students and familiar with courses to them.
3. Weekly Mentoring sessions are also organized in the form of Remedial teaching to diagnose and solve day to day queries of the concerned students.
4. One-week online academic orientation was started by the CDOE from academic session 2024-25.
5. Combined mode PCP is organized for the students of CDOE.
6. Online monitoring session of one hour per week has been organized for the students of all programmes.
7. The students were also connected through Google Class Room, WhatsApp, Facebook page and e-mail.
8. ODL examination was conducted for theory/practical exams and viva-voce.
9. ONLINE examinations were conducted for ONLINE programmes.
10. Five full-flagged online programmes were started from the session January, 2021.
11. Assignments accepted through online portal since the session 2018.
12. Three tier students grievance cell activated in the Directorate.

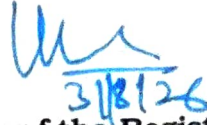
