It is intimated that a proposal has been submitted to the Ministry of Social Justice & Empowerment, Government of India, requesting the re-opening of the National Scholarship Portal (NSP) for the Academic Year 2025-26 to facilitate submission of fresh applications, correction of defective applications and completion of the pending verification process.

In anticipation of approval from the Ministry, all concerned Scheme Implementing Departments are hereby informed to keep their respective Institute Nodal Officers (INOs), District Officers (DOs), and other concerned officials in readiness so that the proposed activities can be undertaken immediately upon re-opening of the portal. The tentative schedule proposed to the Ministry is as follows:

Process	Responsible Authority	Tentative Timeline
Student Registration	Student	From 18.07.2026 to 31.07.2026
Institute Verification	INO	Within 10 days of student applies
District Verification	DNO	Within 7 days after INO verification
State Approval	SNO	Within 7 days after DNO Verification
PFMS Validation & Disbursal	SNO/PFMS	Within 4 days of SNO approval
