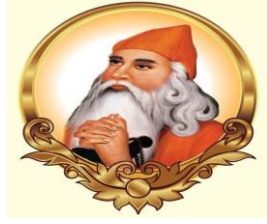

About Guru Jambheshwar Ji Maharaj



Guru Jambheshwar Ji Maharaj was a great saint, philosopher and environmentalist of the 15 century. He was born in the family of Shri Lohat Ji Panwar and Mata Hansa Devi on Bhadrapada Krishna Paksha Ashtami (Janmashtami), Vikram Samvat 1508 (1451 A.D.) in Pipasar village of Nagaur district of Rajasthan. Guru Jambheshwar Ji Maharaj founded the Bishnoi sect in Vikram Samvat 1542 (1485 A.D.) at Samrathal Dhaura on Kartik Krishna Ashtami. He spent the remaining 51 years of his life spreading his great vision. The First shabad uttered at the age of 7 years since Birth by Guru Jambheshwar Ji is **“Guru chinho guru chinh purohit...!”** to a Brahmin called to cure his dumbness. Considering the miraculous powers of Guru Jambheshwar Ji and his teachings, Guru Jambheshwar Ji Maharaj is popularly considered as Vishnu Swarup. His teachings influenced both the ruling class and the common class.

Guru Jambheshwar Ji Maharaj had said – **“Jeev daya palaanee, rukh leelo na ghav”**

Which means – "Have compassion for all living beings, and don't cut the green trees".

He raised his voice against the rituals and formalities of contemporary social system. He was a great visionary who had foreseen the consequences of man's actions destroying nature for economic development. He saw the need for environmental protection and weaved his principles into religious commandments so that people could internalise those principles easily. He teaches love, peace, kindness, simplicity, honesty, compassion, forgiveness, hard work, good moral character, internal and external purity.

At village Khejarli of Jodhpur State, in Vikram Samvat 1787 (1730 A.D.), under the influence of Guru Jambheshwar Ji Maharaj's teachings, Smt. Amrita Devi Ji and 362 Bishnoi brothers and sisters, sacrificed their lives to save Khejadi trees from being cut by moving their heads forward saying

"Sar Sathe Rukh Rahe, To Bhi Saston Jaan",

Which means “Even if a tree is saved in exchange of a head, it is still a cheaper deal”.

The Khejarali village event was the supreme sacrifice worldwide to protect the trees. Khejarali (Jodhpur) is the place where the Chipko movement originated in India Centuries before the S.L. Bahuguna led Chipko movement. This collective sacrifice of human lives to protect the Khejri tree is a unique phenomenon worldwide.

Guru Jambheshwar Ji Maharaj founded 29 rules. Out of these, eight prescribe to preserve biodiversity and encourage good animal husbandry, seven provide directions for healthy social behaviour, and ten are directed towards personal hygiene and maintaining essential good health. The other four commandments provide guidelines for worshipping Vishnu daily. He expounded his religious philosophy and the essence of these principles in verses. These vibrant and passionate spiritual verses have a vigour of their own and are distinguished by their vivid conversational style and moral exhortation. Guru Ji achieved `Nirvana' in Vikram Samvat 1593 (1536 A.D.) at Lalasar, District Bikaner, Rajasthan.

A fundamental “Shabad” by Guru Jambheshwar Ji-

**“Vishnu Vishnu tu bhan re prani, paii key lakh upayun,
Rattan kayo baikunth baaso, tera jara maran bhaya bhajun”**

Which means, “O human being, recites Vishnu Vishnu continuously so that the recital multiplies in number. This would relieve you from the fear of old age and death”.

“Jeeya Nai Jugati or Mhan (Moova) Nai Mugati”.

FOREWORD

Guru Jambheshwar University of Science & Technology started its journey on 20th October, 1995 at Hisar, Haryana. The University was established under the Act of State Legislature that facilitates excellence in teaching and research in promising areas of higher education with focus on new frontiers of Science & Technology, Engineering Studies, Environmental Studies, Media Studies, Pharmaceutical Sciences, Management Studies, Yoga Science, Physiotherapy, Humanities and Social Sciences and also to achieve excellence in these and related fields. The University has achieved several milestones since its establishment. The University is duly recognized by the University Grants Commission (UGC) under Section 2(f) for recognition of degrees on 11.1.1996 and under Section 12(B) of the UGC Act for central assistance on 7.2.1997. Today, the University spreads over 372 acres of lush green campus with 10 spacious Teaching Blocks, 31 Departments classified under 9 Faculties which houses 93 Regular Programmes the campus apart from this, University also offer 3 Under Graduate, 8 Post Graduate Programmes, 14 Diploma/Certificate Programmes through Open and Distance Learning mode and 12 Programmes through Online mode along with 32 Certificate Courses in collaboration with HKCL. The University also offers Ph.D. degree Programmes in the most of the Departments. The University houses world- class facilities such as the Ch. Ranbir Singh Auditorium, Dr. A.P.J. Abdul Kalam Central Instrumentation Laboratory, Pandit Deendayal Upadhyaya Innovation & Incubation Centre, advanced computing facilities, a central library with 4 lakh+ resources, and comprehensive sports and hostel infrastructure.

The National Assessment and Accreditation Council (NAAC) has recently accredited this University at A+ Grade in the 4th cycle w.e.f. 18.10.2022 to 17.10.2027. Times Higher Education World University Rankings 2025 and **33rd in the India in the ‘Physical Sciences’ subject category rankings** in The Times Higher Education World University Rankings 2025, 401-500 in the world and 41st in India in The Young University Rankings 2024, Rank Band 501-600 in Asia and 71st in India in Asia University Rankings 2024, 801-1000 ‘Engineering & Technology’ category ranking 2024 in the world and 43rd in India. The University has also been ranked 22nd in India and 639th in the world in UI Green Metric World University Rankings 2024. The University has also been ranked 1045th, Grade ‘A’ and Band ‘GOLD’ in the Global University (GU) Ranking (London) in 2023. The University has also been admitted for the 3rd time for Global Initiative of Academic Network (GIAN) Phase-III Scheme, a prestigious scheme of MHRD (MoE).

The University has constantly motivated and encouraged interdisciplinary collaboration and Research. More than **5300** research papers have been published by the faculty and researchers in peer reviewed journals of repute which are listed in SCOPUS with 1,15,080 citations and our average paper citations is 22.83. The h-index of the University has also gone upto 132. This is the highest h-index of any University in the State of Haryana.

The Centre for Distance and Online Education has made remarkable progress with a mission to deliver higher education at the door steps of learners since its inception in the year 1997. CHAPTER-I

THE UNIVERSITY

1.1 The Guru Jambheshwar University of Science & Technology, Hisar, was established on October 20, 1995 by an Act of the Legislature of the State of Haryana with the objectives ‘to facilitate and promote studies and research in emerging areas of higher education with focus on new frontiers of technology, pharmacy, environmental studies, non-conventional energy sources and management studies and also to achieve excellence in these and connected fields’. It was formally inaugurated on November 1, 1995. It is named after Guru Jambheshwar Ji Maharaj, a saint environmentalist of 15th century. Keeping in view the nature of courses offered at the University and the mandate for which it had been established the name of the University has been changed as Guru Jambheshwar University of Science & Technology.

The University enjoys a rare distinction of getting recognized by the University Grants Commission under Section 2 (f) for recognition of degrees, on 11.1.1996 and, under section 12(B) of the UGC Act to be eligible for central assistance on 7.2.1997, i.e., within 15 months of its coming into being. The University opted for accreditation by National Assessment and Accreditation Council (NAAC), an autonomous organization of the University Grants Commission, in 2001-02. As a result of the exercise, the NAAC accredited this University at “A” level (Institutional score 85%) in 2002 and has been again re-accredited by NAAC three times again with grade “A” with CGPA 3.28 upto 09.12.2021 and University got rank band 101-150 in NIRF Ranking 2024. Now University is recently accredited with ‘A+’ Grade from NAAC valid upto 2027.

1.2 LOCATION

The University is situated at Hisar, a rapidly growing town situated at about 167 Kms. from Delhi on Delhi-Rohtak-Hisar-Sirsa-Fazilka National Highway (NH-152) and at a distance of about 231 Kms. from Chandigarh on NH-65. It is well connected by rail and road. Hisar is one of the principal cities catering to the administrative and commercial needs of rural population. It is a major centre of higher education and research with three major Universities of the State, a number of research Institutions, degree colleges, breeding farms and a growing industrial environment. An Army Cantonment located in Hisar enriches its cultural life.

1.3 JURISDICTION

The State Government vide notification No. S.O.7/H.A. 17/1995/S.4/17 dated 21.06.2017 has redefined the jurisdiction and authorized the University to exercise its power on all type of colleges of District Hisar.

1.4 CAMPUS

The University is situated over a sprawling area of about 372 acres. The campus is laid out with picturesque landscape, numerous buildings of various sizes and wide road network. It presents a spectacle of harmony in architecture and natural beauty. Approximately 275 acres of area has been developed with all providing modern facilities such as road networks, sewerage, pipe lines for water, electricity supply and parks have been developed at various places. The whole Campus is also connected to Internet facility. The University has 10 teaching blocks along with separate building of

Haryana School of Business, Mechanical, Bio-Nano and Physics Departments. There are residential houses of different types for various categories of employees. Construction work for more Staff quarters is under progress. The University has the Branch of nationalized banks with ATM facility and a post office in the Shopping Complex. Beautification of the campus is being attached priority to provide healthy and pollution free environment on the campus. The University is running its Cafeteria. Besides a spacious Library & Guest House/Faculty House are also located on the Campus.

1.5 HOSTELS

There are Nine Hostels (four for boys, four for girls and a working women hostel) in the University, which have capacity of about 2000 residents. The hostels are provided with colour Televisions, Chess Board, Carom Board, Chinese Checker Board, Badminton, Table Tennis, Newspaper Stands etc. for recreation and entertainment of the students within the hostel premises. All the hostels have been provided with modern facilities such as Electric Geyser, Music System, Telephone Facilities, Desert Coolers, Water Coolers fitted with aqua guards, insect killers and adequate play grounds. The Girls hostels have been provided with physical fitness machines for jogging, cycling and abdominal exerciser. All hostels are connected with Internet facility.

1.6 ACADEMIC PROGRAMMES

The University offers a wide range of academic programmes/courses at post-graduate and undergraduate level. All these programmes are designed by taking into consideration the special needs of the market and the industry and the Model Curricula has been designed in accordance with model course curriculum of the UGC/AICTE. Emphasis is laid on both theoretical and practical training, knowledge and skilling for exposing students to the latest developments in the various areas of science, and technology. For the purpose, the University invites academicians, professionals and researchers from various Institutions and industries. Adequate training and placement facilities are available for the students. The University also arranges campus interviews. Workshops, Seminars and Symposia which are conducted regularly. In-plant industrial training is an essential component of most of the courses. In addition to these, the University also offers programmes through Distance Mode as mentioned in the Prospectus which are entitled by DEB,UGC.

CHAPTER-II

THE CENTRE FOR DISTANCE AND ONLINE EDUCATION

The Centre for Distance and Online Education of this University was established in 1997 with four programmes namely; MBA, PGDCA, BBA & CIC. Since then a lot of progress has been made in terms of number of programmes, number of students enrolled, production of quality Self-Learning Material (SLM) etc. Not only the new programmes were added, but some of the programmes were replaced by the new ones so as to make them highly job-oriented and enable the students to pursue them while being in job and self-employment. At present, 8 Post Graduate Programmes, 3 Under Graduate, 14 Diploma/Certificate Programmes through Open and Distance Learning mode and 8 Post Graduate, 1 Under Graduate, 3 Diploma/Certificate Programmes through Online mode along with 32 Certificate Courses in collaboration with HKCL. For the admitted students, the Centre for Distance and Online Education organizes Personal Contact Programmes (PCPs)/Doubt Classes during which the teachers of parent departments and the programme co-coordinators hold classes and satisfy the queries of the students. There is also well equipped Computer Lab for students with internet connection. The study material has been prepared by the Centre for Distance and Online Education with the association of specialists in the respective areas and the same is updated as and when the changes are brought in the programme curriculum as per needs of the market. In order to have the interest of the students closely watched, the Centre for Distance and Online Education has appointed teachers/programme coordinators in the respective disciplines programme. Notwithstanding the moderate amount of fee charged for each programme, the students have the facility to pay the same in half yearly installments so that the students with limited financial resources can also afford to acquire quality education. In addition to it, the students of Centre for Distance and Online Education get the benefit of Post Matric Scholarship (PMS) released by the Government of Haryana. From the session 2015-16 onwards, the on-line admission process was adopted to facilitate the student spread all over India and abroad.

CHAPTER-IV

About the Programmes

The Programmes offered by Centre for Distance and Online Education, Guru Jambheshwar University of Science & Technology are entitled by DEB (UGC). Internal & External Examinations are conducted semester-wise with the scheme of **70% for End term Examination and 30% for Internal Assessment except M.A. (Hindi), B.A. Mass Communication and B.A. Arts where in End term Examination is of 80% and Internal Examination is of 20%.**

In external major exam there will be nine questions in all taking two questions from each unit and question number 1 is compulsory (Question No. 1). The compulsory question will consist of seven/eight short answer type questions, each of two marks and will be distributed over the whole syllabus. The candidate is required to attempt five questions selecting one from each unit and the compulsory question.

1. MASTER OF ARTS (MASS COMMUNICATION) AND LATERAL ENTRY

The Centre for Distance and Online Education introduced a two years programme of M.A (Mass Communication) along with a provision of lateral entry in 2nd year. This programme has been designed in such a way that students will make their career in print media, electronic media, public relations, advertising, social media, academics and media research. The programme curriculum also has been designed according to the UGC's NET syllabus. This programme exposes the students to various aspects of Mass Communication as given in the programme structure.

PROVISION FOR ADMISSION OF FOREIGN STUDENTS

FOR ONLINE PROGRAMME(S) ONLY

- i) A uniform fee of USD 500 per annum for the duration of the programmes (UG and PG) will be charged from students of SAARC Countries admitted in online programmes of Centre for Distance and Online Education.
- ii) A uniform fee of USD 1000 per annum for the duration of the under Graduate programmes will be charged from students of other than SAARC (Non-SAARC) Countries admitted in online programme of Centre for Distance and Online Education.
- iii) A uniform fee of USD 1500 per annum for the duration of the under Post-Graduate programmes will be charged from students of other than SAARC (Non-SAARC) Countries admitted in online programme of Centre for Distance and Online Education.

Note:

- 1. In case of Online Programmes there is no provision for any type of fee concession.**

IMPORTANT NOTES REGARDING FEE (FOR ALL PROGRAMMES)

- i) The first installment of fee is to be deposited along with the registration form without which the candidature will be rejected.
- ii) The fee structure given in the above chapter includes Admission fee, Registration fee, Continuation fee, Examination fee, and Study material fee, fee for PCP and Alumni fee. Students are advised not to make any excess payment. However, Rs.1300/- will be paid separately as examination fee for re-appear papers.
- iii) The candidates taking admission in the University have to deposit the required fee by online mode of payment through Net Banking/Debit/Credit Card/UPI. In case of any another kind of fee, like re-appear, migration, Duplicate DMC/Degree fee is to be deposited through Miscellaneous Fees on CDOE website at the link <http://web.gjuonline.ac.in>
- iv) In case of non-receipt of any type of dues/fees or part thereof, upto above said dates, the candidature of the candidate will be treated as cancelled. Thereafter, the candidature can be restored in genuine cases during the session on payment of balance dues alongwith late fee of Rs.500/- per month subject to a maximum of Rs. 2000/- and readmission fee of Rs. 1000/- with the approval of Director (CDOE). No adjustment/refund of fee paid will be admissible.

In case of already admitted students, if a candidate drops for whole session(s) and fails to submit the required fee as per schedule given in the prospectus and submits the fee after a gap of session/year, he/she can be re-admitted on payment of Rs.1000/- as re-admission fee. Provided further he/she will have to deposit all dues with late fee as per the schedule/rule given in the prospectus.

- v) All admissions/enrolments are provisional. However, the University reserves the right to cancel an admission, if any deficiency for admission to a course is found at a later stage.
- vi) 50% concession of the total fees to this university employees (GJUS&T, Hisar) and their dependents and 75% concession of the total fees to Class-III employees of this University (GJUS&T, Hisar) and their dependents and full fee concession in case of Class-IV employees of this University and their wards (other than Post Matric Scholarship cases) may be allowed in regular, part time, self-financed programmes in the University Teaching Departments and Programmes through Distance Education mode. In case of Contractual staff 25% concession for the total fee of the installment submitted during his/her period of working in this University is allowed.

Further, the wards/dependent children of HKRNL employees of the University be given fee concession in all regular programmes at par with wards of University regular employees as under:

wards of HKRNL group-D employees	full fee concession of the total fee
wards of HKRNL group-C employees	75% concession of the total fee

Note: No fee concession will be applicable in case of admission through Marketing Channel Partners (MCP).

- vii) The retired employees of this University may be treated at par with the serving employees for the purpose of fee concession for their wards /spouses. The ward of deceased employee (including pensioners) of this University is granted 100% Tuition Fee Concession.
- viii) 25% concession of total fees of Distance Learning Programmes will be allowed to the students pursuing regular courses in GJUS&T, Hisar or any other recognized University/College, who are interested to simultaneously join a Distance Learning Programme. The candidate claiming this concession will be required to produce a certificate of *bona fide* student from the Head of the Institution concerned.

As per the policy of UGC D.O. No. 1-6/2007 (CPP-II) (New) dated 13th April, 2022 regarding **Guidelines for Pursuing Two Academic Programmes Simultaneously**

- A student can pursue two full time academic programmes in physical mode provided that in such cases, class timings for one programme do not overlap with the class timings of the other programme.
- A student can pursue two academic programmes, one in full time physical mode and another in Open and Distance Learning (ODL)/ online mode; or up to two ODL/Online programmes simultaneously.
- Degree or diploma programmes under ODL/Online mode shall be perused with only such HEIs which are recognized by UGC/Statutory Council/ Govt. of India for running such programmes.
- Degree or diploma programmes under these guidelines shall be governed by the Regulations notified by the UGC and also by the respective statutory/professional councils, wherever applicable.
- These guidelines shall come into effect from the date of their notification by the UGC. No retrospective benefit can be claimed by the students who have already done two academic programmes simultaneously prior to the notification of these guidelines.

The above said guidelines are available on the CDOE Website.

- ix) “The Scheduled Caste students of Haryana whose family income from all sources is up to Rs. 2.5 Lacs per annum as prescribed by the State Govt. for Post Matric Scholarship and who produces, at the time of admission, the “Caste” and "Income" certificates issued by the competent authority and updated Parivar Pehchan Patra (PPP), are not required to pay any kind of fees and they may pay a sum of Rs.1000/- (Refundable) as security/caution money. The eligible SC students will apply the Post Matric Scholarship form on the concerned portal i.e. <https://harchhatravratti.highereduhry.ac.in>. In case the SC students does not apply for Post Matric Scholarship OR is found not eligible for award of Post Matric Scholarship OR being eligible, he/she is not awarded Post Matric Scholarship due to one or other reason, and if the fees is not deposited by the students to the University within 7 days after receiving the complete Post Matric Scholarship amount in his/her account. The students concerned will be liable to pay his/her fee alongwith late fine of Rs. 10/- per day subject to maximum Rs. 2500/-. DMC and Degree/PDC will be issued only after depositing the PMS amount/requisite fee.”

Those students who have applied for above said scholarship and fulfil conditions:

- a. Applied for scholarship well in time.
- b. Are eligible for scholarship?
- c. Are eligible for the respective course?

But the same have not been received from the Government and if they wish to submit their full fees for taking their DMC/result declaration. In such cases they do not have to pay the late fee of Rs. 10/- per day. Further, if because of any reason, their scholarship is not received from the Govt. the deposited fee paid by the students will be forfeited.

Note: 1. The above said guidelines are subject to the directions of Scholarship and SC/ST Cell of the University issued from time to time. The same will be notified on Centre for Distance and Online Education Website and be treated as final.

2. In case of PMS, the candidate have to upload the undertaking (Annexure-IV of the Prospectus) which is mandatory for claiming the scholarship.

- x) The fee concession on the pattern of Guru Jambheshwar University of Science & Technology employees will also be extended to the employees of the office of the Directorate of Technical Education Haryana posted in the Head Office at Panchkula and the Audit staff posted in Guru Jambheshwar University of Science & Technology, Hisar for pursuing studies in all the courses being run by the University. However, the Audit Staff will be entitled to avail such facility up to the period till they remain posted in Guru Jambheshwar University of Science & Technology, Hisar.
- xi) The students must remit the fee of subsequent semesters/installments as per the schedule without waiting for the result so as to enable the Centre for Distance and Online Education to supply the study material in time.
- xii) In case of sudden demise of any student during study the fees paid by him/her for the session of demise will be refunded, if claimed by parents
- xiii) 25% concession of the total fees to serving/ retired military personal up to the rank of N.C.O. or of military personal killed or incapacitated wholly or partially during the war and their wards, will be allowed.

 - a) Time span = N+2 years for the completion of programme.
Where N stands for the normal or minimum duration prescribed for completion of the programme.
 - b) In exceptional circumstances a further extension of one more year may be granted. The exceptional circumstances be spelt out clearly by the relevant statutory body of the University.
 - c) During the extended period, the student shall be considered as a private candidate and also not be eligible for ranking.
2. Ordinarily, no student will be given time beyond the extended period of two years. However, in exceptional circumstances and on the basis of the merits of each case, University may allow a student one more year for completion of the programme.
3. Further, the mercy chance, if any will be given within maximum allowed period of the programme as per UGC guidelines. In normal circumstances, only two chances will be given to pass re-appear examination.

CHAPTER – VII

Important Notes, General Information and Admission Process

7.1 About the Examination/Examination form

The examination of semester programmes shall be held twice in a year, i.e., in the months of December-January and June-July or on such dates as may be fixed by the Controller of Examinations. The examination of re-appearing candidates of odd semesters will be held only with the odd semester examinations and the examinations for the candidates re-appearing in even semester will be held only with even semester examinations. The examination of re-appearing candidates of annual courses will also be held with examinations of odd semester courses, in addition to their annual examinations.

7.2 Reappear Schedule will be uploaded on the CDOE Website before commencement of examination.

Note:

- i) The candidates can submit their examination forms for re-appear/ improvement within 15 days without any late fee from the date of declaration of the result including the date of uploading of result on the website. Thereafter, late fees will be charged as per the schedule notified.
- ii) The University reserves the right to alter the schedule/ provisions whenever considered necessary.
- iii) The examination form and fee for re-appear, once deposited shall not be permitted to be withdrawn. Such examination fee is neither refundable nor adjustable for any other course or subsequent examination.
- iv) The Re-appear examination forms along with requisite fee and required documents are to be sent directly to the Deputy Registrar/Assistant Registrar (Results), Guru Jambheshwar University of Science & Technology, Hisar.

7.3 Instructions regarding Re-appear/Mercy Chance/Improvement forms.

- D) A candidate who gets Re-appear in one or more papers shall pay a fee of Rs.1300/- for the whole examination. A candidate have to fill online Re-appear form at the CDOE website and students can also fill their online Re-appear form on the direct link available in their online results at CDOE website i.e. <http://web.gjuonline.ac.in>. A candidate who has been placed under re-appear in the more than one examination is required to apply separately for re-appear(s) on separate examination form meant for re-appear along with requisite fee.
- i) Grant of mercy chance is allowed within maximum duration of programme i.e. N+2 (where N stands for normal duration of course) to a student who got reappear and has availed two chances to clear the re-appear paper (s) of a particular semester/year, on recommendations of Chairperson of the Deptt., Director (CDOE). Principal of the concerned affiliated college. Such candidates will have to pay a fee of Rs.5000/- per paper subject to maximum of Rs.10000/- per semester/year, as the case may be and the candidate will have to appear in the examination as and when to be conducted for that particular semester. The schedule for filling examination form for mercy chance students will remain the same as notified from time to time for odd/even/annual exams without late fee. **No application for mercy chance will be entertained after exhausting of examination schedule including maximum late fee.**
- iii) A candidate who has passed the final examination of this University and is desirous of improving his/her performance, will be allowed to appear in the end semester examinations (major tests) only as an ex-student in odd/even semester/annual examinations, as the case may be twice, upto one year after the maximum period permissible N+2 (where N stands for normal duration of course). Those candidates who have taken Migration Certificate from this University will not be eligible for appearing in Improvement examination. Further, those eligible students who want improvement of “Division”/

“Score” after minimum duration of programme may apply with the recommendations of Chairperson of the Deptt., Director (CDOE), Principal of the concerned affiliated college with normal fee as per notified schedule of examinations within permissible maximum duration of course. After maximum duration (N+2), the candidates will have to pay a fee of Rs.5000/- per paper., subject to maximum of Rs.10000/- per semester/year, as the case may be and the candidate will have to appear in the examination as and when being conducting for that particular semester/year. The schedule for filling the examination form for improvement students will remain the same as notified from time to time for odd/even/annual exams without late fee. No application for improvement will be entertained after expiry of scheduled date of without late fee.

7.4 The examination center will ordinarily be created at the University campus/ affiliated colleges or at any and other place to be decided accordingly to the territorial jurisdiction of University from time to time. Change of center of theory/practical examination can be allowed in genuine cases with a valid proof by the Director or the officer authorized by him up to 10 days before the commencement of the examination, on valid grounds on payment of Rs.5000/- and in case for that supplementary examination, if the student wants to change the examination center, he/she allowed in genuine cases with a valid proof (proof must not be older than 6 months at the time of applying) by Controller of Examinations up-to 7 days before the commencement of the examination on payment of Rs.5000/-. However, this option will not confer any absolute right to the students for change of exam centers.

Note:

- i) The students of above mentioned programmes are required to submit their Synopsis/Project Reports/Thesis/ Training Reports/Production Portfolio duly complete in all respects upto the dates mentioned against each without late fee. Thereafter, these shall be accepted with late fee of Rs.1000/- up-to one month by the Director (CDOE). However, in exceptional cases, the Director (CDOE) may allow a candidate to submit his/her Synopsis/Project Reports/Thesis/ Training Reports/Production Portfolio with late fee of Rs.2000/- up-to next one month only. If a candidate still fails to submit the same, he/she will be treated as "absent" and will be treated a re-appear case. He/she can apply for re-appear within the time period permissible under the rules.
- ii) For supplementary examinations, student have to submit the Synopsis/Project Reports/Thesis/ Training Reports/Production Portfolio alongwith reappear form up-to 15 days from the last date of apply for reappear examination with maximum late fee. In case the student fails to submit the same within duration, the same will be accepted with the approval of Director (CDOE) alongwith late fee of

Rs.1000/- upto one month and with late fee of Rs. 2000/- upto next one month from the last date of apply for reappear examination with maximum late fee. If a candidate still fails to submit the same within duration with late fee of Rs. 2000/-, he/she will be treated as "absent" and he /she can apply for re-appear for next session within the time period permissible under the rules.

7.7 ABOUT ONLINE ADMISSION FORM FOR OPEN AND DISTANCE LAERNING

- i) Incomplete admission form, in any respect and without requisite fee will be summarily rejected. The students seeking admission must ensure that they are eligible for taking admission. In case of any doubt they can consult the Centre for Distance and Online Education before submission of admission form.
- ii) All the admissions are made online by filling Online Admission Form. The procedure of filling the online application form is a six step procedure, which is mentioned below:

STEP ONE: Create ABC ID

STEP TWO: Create UGC/DEB ID

STEP THREE: CANDIDATE REGISTRATION: Click the registration form and fill the necessary details like: Name of Candidate, Father's Name, Date of Birth, Category, Name of Programme etc. by paying the pre-requisite registration cum application form fees.

STEP FOUR: PAYMENT OPTION: Registered candidate may deposit fee by any of the following modes of payment:

- a. NET BANKING
- b. DEBIT CARD
- c. CREDIT CARD
- d. UPI PAYMENT

STEP FIVE: FILLING OF APPLICATION FORM: After Registration and depositing of fee, registered candidate may fill the complete application form with all the fields given in the form.

UPLOADING DOCUMENTS: In final step, the following scanned documents (all documents /image/signature should be in "jpg", "gif", "bmp", "jpeg" (format only) are to be uploaded:

- a) 10th Mark Sheet (for the purpose of proof of Name of candidate, Date of Birth, Father's and Mother's Name etc.) not greater than 500kb.
- b) 12th Mark Sheet not greater than 500kb.
- c) Mark sheet of qualifying exam along with degree of lower examination, if any, not greater than 500kb.
- d) Photograph of candidate (should not be greater than 75kb) and Maximum size (Width 132px Height 170px) Minimum Size (Width 102px Height 140px).
- e) Signature of candidate (should not be greater than 50kb) and Maximum size (Width 210px Height 80px) Minimum Size (Width 150px Height 50px).
- f) Proof of fee concession, if applicable not greater than 500kb.
- g) Caste Certificate, if applicable, not greater than 500kb.

STEP SIX: GENERATING PREVIEW: After uploading the document, a preview of the complete application will be generated. If necessary, academic information can be edited before locking.

LOCK FORM TO GENERATE ENROLLMENT NO. AND ADMISSION LETTER: Finally the application form is locked to generate enrolment No. and admission letter.

- iii) The student have to lock the admission form and complete the admission process upto the last date of admission.

- iv) The admission form will be locked automatically thereafter. The admission form will be unlocked after above said stipulated time with a fine of Rs. 500/- with the permission of Director (CDOE) within 15 days thereafter. In case of additional documents required to be uploaded after locking of admission form a fine of Rs. 500/- will be charged.
- v) The candidate appearing in the qualifying examination and whose result has not yet been declared may apply for admission to various programme as per schedule of admissions, subject to the condition that the candidate will have to produce an evidence of their having cleared the qualifying examination by 31st December 2025, failing which their candidature for admission will be treated as cancelled and he/she will be treated as ineligible. No request after this date will be entertained.
- vi) Students have to get their original certificates verified in the Centre for Distance and Online Education after getting the admission either in person/through post. For safe return of original certificates after their verification by the office, the students admitted are advised to send a self-addressed envelope of size 10” x 12” bearing postage stamps worth Rs.55/-. **In case of genuine request of the students on the recommendation of the respective Programme Co-ordinator with the approval of the Director (CDOE) student will be allowed for online verification of original document through video conferencing along with a special fee of Rs. 500/-.** In case the student will upload the attested document from 1st Class Gazetted Government Officer then there is no need of original document verification. The last date for verification of original documents is 31.12.2025 for all the courses. After this date, a late fee of Rs. 500/- will be charged before 15 days of the commencement of the examinations. **Thereafter the candidature of the candidate will be treated as cancelled.** In genuine cases, the candidature can be restored with the recommendations of the Director, Centre for Distance and Online Education with a fine of Rs. 1000/-.
- vii) Submission of fee, Dispatch of study material and submission of assignment does not mean that a candidate is eligible for that particular course in which he/she has applied.
- viii) The University reserves the right to change the programme curriculum whenever it will be felt that the change/modification could best serve the interest of the students and the potential employers.
- ix) Suppression of any information or furnishing any false information by a candidate will lead to immediate cancellation of his/her admission at any time. In such cases, fee paid shall not be refunded.
- x) For change of address, the Centre for Distance and Online Education should be informed at least 4 weeks in advance to avoid any misplacement of the study material and any other correspondence.
- xi) The information given is an indication of the University's plans as on date of publication of this document. Details can be modified from time to time for academic and operational reasons. The students will be governed by latest regulations applicable to them during academic year.
- xii) In the event of any inconsistency in the rules framed for admission or in the event of any clarification with respect to the above said rules/instructions, the matter shall be referred to the Vice-Chancellor for interpretation and the interpretation given by the Vice-Chancellor shall be final. The Vice-Chancellor is also competent to remove any inconsistency and decide as to which provision shall take precedence over the other.
- xiii) Any legal dispute relating to admission of a student will be subject to jurisdiction of the courts at Hisar only.
- xiv) The eligible students who have paid their first installment of fees will be informed of their enrolment numbers (which will also be mentioned on the Identity Card). This enrollment No. will remain same

and will continue for the entire duration of the programme. The same number will be used as examination Roll Number of the student. Duplicate enrolment card will be issued by the Centre for Distance and Online Education only on payment of Rs. 500/-.

- xv) There is no bar of passing of any paper for promotion to 2nd and subsequent years/semesters. However, the total duration to complete the course will be as per Chapter VI.
- xvi) M.A.(Mass Communication) 2nd year is also allowed through lateral entry scheme subject to passing the qualifying examination from the University / Institution as per eligibility mentioned in Chapter-III.

7.8 CHANGE OF PROGRAMME/SUBJECT/SPECIALIZATION AND MODE FROM REGULAR TO DISTANCE MODE

The candidates are advised to check their eligibility and then apply for the concerned programme.

- i) In case student wants to Change his/her programme, he/she can change his/her programme with a fee of Rs. 1000/- alongwith balance fee, upto before the last date of admission. If the balance fee after change of programme is excess then the same will be forfeited.
- ii) In case student wants to Change his/her subject/specialization opted (where ever applicable). He/She can change his/her subject/specialization with a fee of Rs. 1000/- upto 15th September.
- iii) In case of change of programme from regular mode of the University Teaching Department to Distance Mode the students will be allowed upto 15 days before the last date of admission with the recommendation of the concerned Chairman/Director. No excess fee, if charged, will be refunded/adjusted. Paid in regular mode will be adjusted in the first installment only of Centre for Distance and Online Education. However, any short of fee will be recovered from the candidate. A fee of Rs. 2000/- will be paid by the student for the change of mode from regular to Distance.
- iv) In case a student wants to change his/her learning mode, ODL to Online or vice-versa, he/she will have to deposit the fee of another desired mode then 100% fee of his/her earlier mode course will be refunded on submission of the request of student upto one week before the last date of admission.

NOTE: In case of MA (Mass Comm.)/MBA/M.Com. student has to Opt his/her specialization upto 30th April i.e before commencement of examination of 2nd semester otherwise above said Clause will be applicable for the same.

7.8(a) SHIFTING OF STUDENT FROM REGULAR MODE PROGRAMME TO OPEN AND DISTANCE LEARNING MODE PROGRAMME

A student after completion of 1st / 2nd year from UTD/Affiliated College of this University but due some reasons he/she could not complete his/her programme may be allowed to complete their programme through Open and Distance Learning mode by taking admission in only 3rd / 5th semester as per following terms and conditions:

- i) that the student will have to complete the degree programme within maximum prescribed duration of programme i.e. N+2 years.
- ii) that the student will pay his/her requisite fee as per the Prospectus of Centre for Distance and Online Education, GJUS&T, Hisar prevailing at that time alongwith Rs. 5000/- processing fee (additional) for transfer/shift from Regular programme to Distance mode programme.
- iii) that the student may be allowed only if his/her previous semesters are fully passed. The student having re-appear will not be considered.
- iv) DMCs already issued will remain same of the previous attended college/University and DMCs of remaining semester will be issued by Centre for Distance and Online Education as the case may be.

- v) that the student will be allowed for only those subjects/courses/specializations which are already existing programme of CDOE.
- vi) that the student has to submit No Dues as well as Character Certificate from the earlier attended college/department of the University.
- vii) that the Degree will be awarded of Centre for Distance and Online Education after successful completion of the course/programme.

7.9 INTER UNIVERSITY MIGRATION CERTIFICATE

The students passing out final examinations seeking inter University migration certificate may apply on the proforma provided in the prospectus (Annexure-I). For this purpose, the proforma duly filled in along with fee of Rs.1000/- is to be deposited through Miscellaneous Fees on CDOE website at the link <http://web.gjuonline.ac.in> and attested copies of DMC of last / final examination passed may be sent to the Centre for Distance and Online Education. In case original migration certificate is lost, the application for duplicate migration certificate along with fee and affidavit from 1st Class Magistrate is required.

7.10 RE-EVALUATION

- i) **A candidate may apply for re-evaluation on the prescribed form as given in the Prospectus (Annexure-II) along with the uploaded/original D.M.C. and the requisite fee of Rs.600/- per paper within 15 days. Provided that the Controller of Examinations in hard and exceptional cases, may permit, with a late fee of Rs.1100/- in case of a candidate who submits the re-evaluation form after stipulated period but not later than 30 days of the uploaded/original DMC of same. No re-evaluation form will be accepted thereafter under any circumstances. However the University have to right to increase/decrease these fees in near future.**
- ii) **The re-evaluation forms along with uploaded/original Detailed Marks Card (DMC) and a photocopy of the original DMC and requisite fee of Rs.600/- per paper is to be deposited through Miscellaneous Fees on CDOE website at the link <http://web.gjuonline.ac.in> along with fee receipt are to be sent directly to the Deputy Registrar / Assistant Registrar (Secrecy), Guru Jambheshwar University of Science & Technology, Hisar.**

- iii) The candidates who have passed the qualifying examination in more than one part, say first year, second year etc. shall be required to send original certificates and attested copies certificates /DMC/Degree of all the parts instead of only the final year of degree.
- iv) In case it is noticed, at any stage, that any bogus certificate/information was submitted by a candidate, his/her candidature shall stand cancelled and degree/diploma/marks sheet, if already issued will be withdrawn and the candidate will be liable to be prosecuted.
- v) After the declaration of the result, DMC of candidates will be sent by Registered Post. If the case is RL (Result Late) or has been declared provisional or cancelled etc. for any reason, the candidate is advised to approach the University immediately with the relevant document to enable the University to take further necessary action accordingly.
- vi) Employment certificate of GJUS&T, Directorate of Technical Education Haryana and University audit staff, military personal and their wards for claiming the fee concession is to be uploaded along with application form.
- vii) Certificate from the serving/ retired military personal upto the rank of N.C.O. or of military personal killed or incapacitated wholly or partially during the war and their wards is required to be uploaded along with application form for claiming the fee concession.
- viii) No admission even "Provisional" shall be made on the basis of certificates issued by the principal of the College/School. Admissions are to be made only on the basis of certificates issued by a recognized Board/University.
- ix) Candidates will have to ensure the filling of registration form, payment of fee, filling of application form, uploading of requisite scanned documents and locking of application form as mentioned in the prospectus, failing which they will themselves be responsible for the consequences including withholding the enrolment-cum-Identity card for appearing in the University examinations.
- x) No fee shall be accepted in the form of money order or cheque. However, the candidates can deposit the fee on the University website by online mode of payment (Net-banking/Credit card/ Debit Card).
- xi) All correspondence relating to submission of re-appear examination form, re-evaluation form and removal of discrepancy if any, in Degree/Diploma/Certificate/DMC etc., should be addressed to the Controller of Examinations, GJUS&T, Hisar.
- xii) **The issue of study material / submission of assignments, if any, subject to checking of eligibility after receipt of admission forms along with fees shall not constitute the basis for claiming admission in a particular programme. If a candidate fails to submit the proof of eligibility within the stipulated period or is found ineligible for admission at a later stage, his/ her admission will be cancelled irrespective of the issuance of study material/ submission of assignments etc.**
- xiii) The result of all the programme will be uploaded on the website of Centre for Distance and Online Education: www.dde.gjust.ac.in as soon as it is declared. The students are advised to visit the website of Centre for Distance and Online Education regularly.

- xiv) **All the assignments will be uploaded on the Centre for Distance and Online Education's website. The candidate are advised to upload the two handwritten assignments within the stipulated time given in the prospectus (Chapter- VIII).**
- xv) The Chief Secretary to Govt. Haryana, Chandigarh conveyed the instructions vide letter No. 22/129/2013-1GS III dated 16.07.2014 regarding prescribing minimum eligibility qualification for the various courses for reserved candidates as per the procedure in compliance of the judgment of Hon'ble Supreme Court passed in CWP No. 7084/2011 for
- “A General candidate requires to have 50% marks, then as per Govt. instructions by giving 5% relaxation, the minimum eligibility marks for a reserved caste candidate should be calculated as under:-
Out of 100 marks needs to less = 5
Out of 1 Marks needs to less = 5/100
Out of 50 marks needs to less = $5/100 \times 50 = 2.50$
This way minimum less marks where general category candidates are required to have 50% in a prescribed qualification, the total required marks for a reserved candidates will be $50 - 2.50 = 47.50$ and not 45.”
- xvi) The student once admitted to a Study Centre will not ordinarily be allowed to change the study centre. However, the change of Study Centre may be allowed on valid grounds in 2nd and 4th semester and it will be effective from 3rd and 5th semester respectively for apportionment of fee except that a student admitted to a Study Centre can become direct student of the University at any stage. For change of Study Centre, No Dues Certificates from his/her Study Centre with a Fee of Rs. 1500/- should be sent to the CDOE at least 15 days before the last date of payment of fee of that semester/installment. No change of Study Centre is permissible at the same station except any genuine reason.

CHAPTER - VIII

PERSONAL CONTACT PROGRAMME (PCP) AND ASSIGNMENT SCHEDULE

The Centre for Distance and Online Education will supply study material in the form of Self Learning Material (SLM)/printed book/lessons. The students may get the same directly from the Centre for Distance and Online Education otherwise it will be sent by post/courier service.

The Personal Contact Programme (PCP) will be arranged for each of the programme by the respective Programme Coordinator(s) either in Online or Offline mode. Mode of PCP will be notified with final schedule after taking approval from the competent authority.
